Minutes of the extraordinary REACT Meeting

11 May 2010, UN Conference Hall

Agenda:

- Overview of situation in East Khatlon following the floods of May 7, 2010;
- REACT Resource mobilization plan.

Discussion points:

- Overview of current situation, including on-going response operations, damage caused and existing needs in Kulob town;
- Overview of the currently situation in other districts of the East Khatlon, including Muminabad, Shurobod, Temurmalik;
- Operational issues faced in Kulob town, especially related to chain of command and newly established tent camp;
- Coordination with Government in terms of operational issues faced at the disaster sites and resource mobilization strategy;
- Distribution of responsibilities between regional REACT (operations) and National REACT (policy, fundraising);
- Information on REACT Rapid Response Team deployment to the disaster affected districts of East Khatlon;
- REACT next steps.

Decision made:

- Develop REACT appeal:
 - o Based on ongoing assessment of REACT Rapid Response Team during 11-12 May 2010;
 - o Covering both relief and recovery – 6 months timeframe;
 - o Covering 5 to 6 sectors: food, education, health, WASH, Shelter & NFI; coordination (?)
 - o In line with schedule given below:
