1. Introduction by Mr. Muzzayanova X, Deputy Chief of Headquarter of Emergency Situations and Civil Defense in Sugd region. (5 minutes)

Mr. Muzzayanov greeted all the participants to regular meeting of REACT in Sugd region and introduced new participants of the meeting from the State organizations of Sugd region

- 2. An overview of information about emergency situations in the territory of Sugd region for January February 2011 (5 min) Muzzayanov H. Deputy Chief of Headquarter of Emergency Situations and Civil Defense in Sugd region
- According to the information of the Headquarters of ES and Civil Defense in Sugd region in the territory of Sugd region two emergency situations were recorded: a car accident on the highway of Khujand Gafurov, which caused the death of 2 people and an explosion of consumer gas station in Khujand.
- 3. An overview of food security in Sugd region, forecasts of Agriculture in 2011 Representative of the Agriculture Office in Sugd region (20 min)

Agriculture Office presented sufficiently general information on the situation of the food security in the region and noted that there is a <u>need for improving the productivity</u> of harvest and work on bank protection in <u>say</u> (a canyon formed by heavy rainfall) and rivers, Kayrakkum reservoir. A member of Ministry of Agriculture noted that the mudflows adversely affect the development of agriculture in the districts.

4. The Presentation of Classification of integrated phases on food stcurity in Sugd Region-Nabieva Sh., UN World Food Program office in Khujand(15 min)

Ms. Nabieva Sh. presented the following accounts and forecast on classification of food security in Sugd Region in detail. In her report she underlined that local and state authorities and NGOs primarily took part in preparation of this report. The most critical areas of food security and the areas where the situation remains to be unsatisfied are formed by providing data and information. Ms. Nabieva noted that such reports are

prepared several times in a year and available to all interested organizations and agencies.

5. Presentation of CASE project / OSCE «Informational Campaigns on Radiation Safety in Taboshar", Zokirov I. and Suleymanov E. NGO " Action for Life" (20 min)

During the presentation of the project "Informational Campaigns on Radiation safety in Taboshar" Mr. Zokirov told the audience of the meeting that this project is a logical continuation of the activities of the OSCE Office in Tajikistan to resolve the problem of radioactive waste in northern Tajikistan. Mr.. Zokirov pointed out that this project is directed at awareness rising of local people on matters of radiation safety as a whole. The project will organize meetings with local people, create an educational video film, install

informational boards and prepare posters and banners on radiation safety in schools and institutions of Taboshar.
