

Minutes of the REACT meeting

September 18th, 2009, 10:00-11:50

1. Introduction

Chair of the meeting has welcomed all participants.

2. Disaster information and updates.

- On 9-10-11.08.09. In Ayni region djamoat Urmetan in the village Vashang was a landslip therefore 12 m. of road, 10 supports of electric mains and 10 supports of communication lines have been destroyed.
- On 21.08.09r. Karaev Rahimboj the citizen of Hujand, street Rahimboeva 34, threw himself to the river and has sunk. The case was transferred to the Office of Public Prosecutor. Under the revealed information, sunken man had problems with his psyche.
- On 9.09.09r. At 02.00 o'clock on the bridge of Ayni region on 137,3 kilometer there was an accident. The motor vehicle of mark GAS 3102, By 89-89 01RT on high speed fallen in a precipice of 15 meters. As a result died three persons and two more victims.
- In the beginning of last week there was a fire in the woods in Shahrستان area. The dehqan households and frontiersmen helped to extinguish the fire.

3. Discussion the draft version of the TECHNICAL REQUIREMENT (ToR) of the REACT group in Sughd region.

UNDP DRMP made the draught variant of the Technical Requirement (ToR) for REACT group in Sughd region. To all members of REACT group was given a printed version of the requirement. After small discussion all participants of REACT decided that they will offer the comments or additions not later than September, 30th 2009

Also there has been discussed idea about creation the storehouse in the Khujand for simplification the work of CoES and the organizations that are members of REACT group in case of ES.

Charles Kelly has suggested to the members of REACT group to update page about ES in a web page of UN TJ. This page wasn't updated for a long time, Charles has noted that, it will be probably closed in cases of absence of the new information from the organizations.

All partners organizations received several copies of the disc.

- CoES and Cd of Sughd region trained 30 aqualungs from the region and 6 from Khujand.
- 25-26 Will be held regional competition on reaction in case of ES and rendering the first help. Participation will be accepted by 8 countries. Competition will be carried out with support of DIPECHO program.
- On September, 27.28th in the Kyrgyzstan planned meeting of CoES members of Tajikistan and Kyrgyzstan.

- UNDP DRMP There will be starting three mitigational projects in Isfara.
