

## Minutes of REACT Zeravshan Valley (ZV) meeting

11 Feb 2011, 10:00 – 12:30

**GIZ** Disaster Preparedness and Training Center in Ayni

**Chairman:** Hoji Muzayanov, Deputy Chief of Sugd Regional HQ on ES and CD

### 1. Introduction

The meeting was opened by **Mr. Hoji Muzayanov**, Deputy Chief of Sugd Regional HQ on ES and CD, by welcoming all the participants and requesting to introduce them. **Mr. Zafar Mirzoboshiev**, head of CoES Unit of Ayni district for the presentation of information on latest disasters occurred in Zeravshan valley. It was informed that on 10 February 2011 at 07.45 there was strong wind in Ayni district but few damages occurred in Urmetan village: the roofing of one house was blown by the wind. This happened due to wrong construction and not following the construction norms. Head of CoES Unit of Kuhistoni Matcha and Penjikent districts reported that no damages have been taken place.

### 2. Brief introduction on TOR for Regional REACT ZV.

**Ms Zarrina Mirzoboeva**, GIZ Project Officer for ZV has introduced with TOR.

She informed that the given TOR sets out common tasks and outputs which REACT ZV should be able to accomplish on a regular basis. **Mr. Hoji Muzayanov** recommended to update the given TOR and requested from the Secretariat to disseminate between all partners and it should be approved by all partners. **Ms Mirzoboeva** agreed to prepare the final version of TOR and send to all partners within next week.

### 3. Information on disaster response activities in 2010 in Ayni district (villages Putkhin, Zoosun)

**Mr. Tuygunov**, First Deputy Chairman, Hukumat Ayni presented the following overview :

**Mr. Tuygunov** thanked all organizations for their support. He also informed the participants that Decree was signed by the President on resettlement households in risk zones in Zeravshan Valley. The participants requested REACT ZV Secretariat to receive the copy of this Decree from Hukumats and distribute among all partners in order to plan future projects.

**4. Planning of activities of REACT partners for 2011.**

**Mr. Muzayanov** suggested to prepare a list of planned activities in 2011 in ZV. The REACT Secretariat will prepare the list by collecting the relevant information from all REACT ZV Partners.

**Mr. Muzayanov** suggested a closer coordination between REACT Sugd and REACT ZV. The first step will be an exchange of information on planned activities for 2011.

**5. News and updates from the partners/Presentation of Mission East DIPECHO VI project**

**Mr. Uktam Eshonov**, from Mission East in Ayni informed on a DIPECHO-06 project, implemented by Mission East. The objective of this project is to strengthen the disaster response capacity in 50 communities. The areas of intervention of this project are Dushanbe, Kulyab, Vose, Penjikent and Ayni. The presentation is attached in Annex 2.

After the presentation participants discussed the issue of the selection of mitigation projects. It was agreed that in the future the selection should be discussed in the REACT meeting and coordinated with REACT partners.

**6. Combination of REACT meetings with general coordination meetings**

**REACT ZV participants decided to have REACT meeting every month and Coordination of non disaster related projects once per two month on the same day of REACT ZV meeting in the same venue.**

WHH/GAA proposed to include in the Agenda for the next meeting a presentation on Communication System, Risk Maps and Lessons Learnt.
