


PROTECTION OF CROPS FROM LOCUST INFESTATION TAJIKISTAN

Due to the drought in 2011, areas inhabited by locust, reached almost 159 000 hectares, which is 54 000 ha more than in 2010. Surveyed area was 245,500 ha, of which 158,516 hectares were occupied and 137 518 hectares treated, including 120 015 hectares against the DMA and 17,503 hectares as against CIT. At the end of the season, State Republican Unitary Enterprise (GROUP) "Combat against Locust" conducted a summer survey of 62 183 ha. The company has been involved in combating the locust, and 66 tractor 1822 manual sprayer, including 300 turbo aero zonal sprayers. More than 4000 workers struggled daily with the locusts. The most serious problems concentrated along the border with Afghanistan, Uzbekistan and Kyrgyzstan, because of limited access in the neutral zone and inaccessible to thousands of acres of foothill areas inhabited by locusts were not treated.

Structure of the State republican Unitary Enterprise "Combat Against Locusts"




